## GENERAL

## Type of organisation

1 The organisation will, upon registration, be a Scottish Charitable Incorporated Organisation (SCIO).

## Scottish principal office

2 The principal office of the organisation will be in Scotland (and must remain in Scotland).

## Name

3 The name of the organisation is "Walkerburn Community Development Trust".

## Purposes

4 The company has been formed to benefit the community of Walkerburn comprising all of the postcode units within postcode area EH43 ("the Community") with the following objects:
4.1 The advancement of community development, including the advancement of rural regeneration;
4.2 To manage community land and associated assets for the benefit of the Community and the public in general as an important part of the protection and sustainable development of Scotland's natural environment, where 'sustainable development' means development which meets the needs of the present without compromising the ability of the future generations to meet their own needs.
4.3 To provide in the interests of social welfare, facilities within the Walkerburn community, for recreation and other leisure time occupation available to the public at large.
4.4 To advance education and in particular to promote opportunities for learning for the benefit of the general public.
4.5 To help young people, particularly those resident in Walkerburn community, to develop their physical, mental and spiritual capacities, such that they may grow to full maturity as individuals and as members of society.
4.6 To promote, establish, operate and/or support other schemes and projects of a charitable nature for the benefit of the community within Walkerburn.

## Powers

5 The organisation has power to do anything which is calculated to further its purposes or is conducive or incidental to doing so.

6 No part of the income or property of the organisation may be paid or transferred (directly or indirectly) to the members - either in the course of the organisation's existence or on dissolution - except where this is done in direct furtherance of the organisation's charitable purposes.

## Liability of members

7 The members of the organisation have no liability to pay any sums to help to meet the debts (or other liabilities) of the organisation if it is wound up; accordingly, if the organisation is unable to meet its debts, the members will not be held responsible.

8 The members and charity trustees have certain legal duties under the Charities and Trustee Investment (Scotland) Act 2005; and clause 7 does not exclude (or limit) any personal liabilities they might incur if they are in breach of those duties or in breach of other legal obligations or duties that apply to them personally.

## General structure

9 The structure of the organisation consists of:-
9.1 the ORDINARY MEMBERS - who have the right to attend members' meetings (including any annual general meeting) and have important powers under the constitution; in particular, the members appoint people to serve on the board and take decisions on changes to the constitution itself;
9.2 the ASSOCiATE MEMBERS who have the right to attend members meetings but who may not vote on any resolution at meetings,
9.3 the BOARD - who hold regular meetings, and generally control the activities of the organisation; for example, the board is responsible for monitoring and controlling the financial position of the organisation.

10 The people serving on the board are referred to in this constitution as CHARITY TRUSTEES.

## MEMBERS

## Qualifications for membership

11 Membership shall be open to any individual aged 16 or over who supports the objects of the organisation and is a resident of, or owns property in, Walkerburn comprising all of the postcode units in postcode area EH43.
11.1 Residents shall be eligible to become ORDINARY MEMBERS with full voting rights at all meetings
11.2 Non-residents, who are owners of property in the EH43 postcode area, are eligible to be ASSOCIATE MEMBERS who shall not have voting rights at meetings, but may be active in the work of the Trust.

12 Employees of the organisation are not eligible for membership.

## Application for membership

13 Any person who wishes to become a member must sign a written application for membership; the application will then be considered by the board at its next board meeting.

14 The board may, at their discretion, refuse to admit any person to membership where they have reasonable grounds to believe that he/she might, if admitted to membership, act in a manner which would damage the reputation of the organisation, undermine the efficiency of its operations and/or disrupt the proper conduct of its meetings.

15 The board cannot deny membership or cause membership to cease without good cause and explanation. Membership may not be restricted or withheld and members may not be expelled on the basis of gender, age (subject to clause 11), ethnic background, disability, caring responsibilities, sexual orientation, religious belief or marital status.

16 The board must notify each applicant promptly (in writing or by e-mail) of its decision on whether or not to admit him/her to membership.

## Register of members

17 The board must keep a register of members, setting out
17.1 for each current member:
17.1.1 his/her full name and address; and
17.1.2 the date on which he/she was registered as a member of the organisation;
17.2 for each former member - for at least six years from the date on he/she ceased to be a member:

### 17.2.1 his/her name; and

17.2.2 the date on which he/she ceased to be a member.

The board must ensure that the register of members is updated within 28 days of any change:
18.1 which arises from a resolution of the board or a resolution passed by the members of the organisation; or
18.2 which is notified to the organisation.

19 If a member or charity trustee of the organisation requests a copy of the register of members, the board must ensure that a copy is supplied to him/her within 28 days, providing the request is reasonable; if the request is made by a member (rather than a charity trustee), the board may provide a copy which has the addresses blanked out.

## Withdrawal from membership

20 Any person who wants to withdraw from membership must give a written notice of withdrawal to the organisation, signed by him/her; he/she will cease to be a member as from the time when the notice is received by the organisation.

## Transfer/cessation of membership

21 Membership of the organisation may not be transferred by a member and will cease on death.

## Expulsion from membership

22 Any person may be expelled from membership by way of a resolution passed by not less than two thirds of those present and voting at a members' meeting, providing the following procedures have been observed:-
22.1 at least 21 days' notice of the intention to propose the resolution must be given to the member concerned, specifying the grounds for the proposed expulsion;
22.2 the member concerned will be entitled to be heard on the resolution at the members' meeting at which the resolution is proposed.

## DECISION-MAKING BY THE MEMBERS

## Members' meetings

23 The board must arrange a meeting of members (an annual general meeting or "AGM") in each calendar year.

24 The gap between one AGM and the next must not be longer than 15 months.

## Power to request the board to arrange a special members' meeting

28 The board must arrange a special members' meeting if they are requested to do so by a notice (which may take the form of two or more documents in the same terms, each signed by one or more members) by members who amount to $5 \%$ or more of the total Ordinary membership of the organisation at the time, providing:
28.1 the notice states the purposes for which the meeting is to be held; and
28.2 those purposes are not inconsistent with the terms of this constitution, the Charities and Trustee (Investment) Scotland Act 2005 or any other statutory provision.

29 If the board receive a notice under clause 28 , the date for the meeting which they arrange in accordance with the notice must not be later than 28 days from the date on which they received the notice.

## Notice of members' meetings

30 At least 14 clear days' notice must be given of any AGM or any special members' meeting.

31 The notice calling a members' meeting must specify in general terms what business is to be dealt with at the meeting; and
31.1 in the case of a resolution to alter the constitution, must set out the exact terms of the proposed alteration(s); or
31.2 in the case of any other resolution falling within clause 47 (requirement for two-thirds majority) must set out the exact terms of the resolution.

32 The reference to "clear days" in clause 30 shall be taken to mean that, in calculating the period of notice,
32.1 the day after the notices are posted (or sent by e-mail) should be excluded; and

## 32.2 the day of the meeting itself should also be excluded.

Notice of every members' meeting must be given to all the members of the organisation, and to all the charity trustees; but the accidental omission to give notice to one or more members will not invalidate the proceedings at the meeting.

34 Any notice which requires to be given to a member under this constitution must be: -
34.1 sent by post to the member, at the address last notified by him/her to the organisation; or
34.2 sent by e-mail to the member, at the e-mail address last notified by him/her to the organisation.

## Procedure at members' meetings

35 No valid decisions can be taken at any members' meeting unless a quorum is present.

36 The quorum for a members' meeting is $1 / 3$ of Ordinary members, present in person or represented by proxy. A member may participate in a meeting of the trust by means of a conference telephone, video conferencing facility or similar communications equipment whereby all the members participating in the meeting can hear each other; a member participating in a meeting in this manner shall be deemed to be present in person at the meeting.

37 If a quorum is not present within 15 minutes after the time at which a members' meeting was due to start - or if a quorum ceases to be present during a members' meeting - the meeting cannot proceed; and fresh notices of meeting will require to be sent out, to deal with the business (or remaining business) which was intended to be conducted.

38 The chair of the organisation should act as chairperson of each members' meeting.

39 If the chair of the organisation is not present within 15 minutes after the time at which the meeting was due to start (or is not willing to act as chairperson), the charity trustees present at the meeting must elect (from among themselves) the person who will act as chairperson of that meeting.

## Voting at members' meetings

40 Every Ordinary member has one vote, which may be given (whether or a show of hands or on a secret ballot) either personally or by proxy.

41 An Ordinary member who wishes to appoint a proxy to vote on his/her behalf at any members' meeting:-
41.1 must give to the organisation a proxy form (in such terms as the board requires), signed by an appropriate officer of the member; or
41.2 must send by electronic means to the organisation at such electronic address as may have been notified to the members for that purpose, a proxy form (in such terms as the board requires)
providing (in either case) the proxy form is received by the organisation at the relevant address not less than 48 hours before the time for holding the meeting (or, as the case may be, adjourned meeting).

42 In calculating the 48-hour period referred to in clause 41, no account shall be taken of any part of a day that is not a working day.

An instrument of proxy which does not comply with the provisions of clause 41 , or which is not lodged or given in accordance with such provisions, shall be invalid.

44 An Ordinary member shall not be entitled to appoint more than one proxy to attend on the same occasion.

45 A proxy appointed to attend and vote at any members' meeting instead of an Ordinary member shall have the same right as the member who appointed him/her to speak at the meeting; and need not be a member of the organisation.

46 All decisions at members' meetings will be made by majority vote - with the exception of the types of resolution listed in clause 47.

47 The following resolutions will be valid only if passed by not less than two thirds of those Ordinary members voting on the resolution at a members' meeting (or if passed by way of a written resolution under clause 51):
47.1 a resolution amending the constitution;
47.2 a resolution expelling a person from membership under article 22;
47.3 a resolution directing the board to take any particular step (or directing the board not to take any particular step);
47.4 a resolution approving the amalgamation of the organisation with another SCIO (or approving the constitution of the new SCIO to be constituted as the successor pursuant to that amalgamation);
47.5 a resolution to the effect that all of the organisation's property, rights and liabilities should be transferred to another SCIO (or agreeing to the transfer from another SCIO of all of its property, rights and liabilities);
47.6 a resolution for the winding up or dissolution of the organisation.

If there is an equal number of votes for and against any resolution, the chairperson of the meeting will be entitled to a second (casting) vote.

49 A resolution put to the vote at a members' meeting will be decided on a show of hands - unless the chairperson (or at least two other Ordinary members present at the meeting) ask for a secret ballot.

50 The chairperson will decide how any secret ballot is to be conducted, and he/she will declare the result of the ballot at the meeting.

## Written resolutions by members

51 A resolution agreed to in writing (or by e-mail) by all the Ordinary members will be as valid as if it had been passed at a members' meeting; the date of the resolution will be taken to be the date on which the last member agreed to it.

## Minutes

52 The board must ensure that proper minutes are kept in relation to all members' meetings.

53 Minutes of members' meetings must include the names of those present; and (so far as possible) should be signed by the chairperson of the meeting.

## BOARD

## Number of charity trustees

54 The maximum number of charity trustees is 9

## Categories of charity trustee

55 In this constitution:
55.1 "Member Trustee" means a charity trustee (drawn from the Ordinary membership of the organisation) elected/appointed under clauses 62 to 65;
55.2 "Co-opted Trustee" means a (non-member) charity trustee appointed by the board under clauses 66 and 67 .

## Maximum/minimum number of charity trustees

56 The maximum number of charity trustees shall be 9 ; out of that number, no more than 7 shall be Member Trustees and no more than 2 shall be Co-opted Trustees.

57 The minimum number of charity trustees shall be 4.
58 At any given time, a majority of the charity trustees must be Member Trustees.

## Eligibility

59 A person shall not be eligible for election/appointment as a Member Trustee unless he/she is an Ordinary member of the organisation; a person appointed as a Co-opted Trustee need not, however, be a member of the organisation.

60 A person will not be eligible for election or appointment as a charity trustee if he/she is: -
60.1 disqualified from being a charity trustee under the Charities and Trustee Investment (Scotland) Act 2005; or
60.2 an employee of the organisation.

## Initial charity trustees

61 The individuals who signed the charity trustee declaration forms which accompanied the application for incorporation of the organisation shall be deemed to have been appointed by the members as charity trustees (within the category of "Member Trustees") with effect from the date of incorporation of the organisation.

## Election, retiral, re-election: Member Trustees

At each AGM, the Ordinary members may (subject to clauses 56 and 60) elect any Ordinary member (providing he/she is willing to act) to be a charity trustee (a "Member Trustee")

63 The board may (subject to clauses 56 and 60) at any time appoint any Ordinary member (providing he/she is willing to act) to be a charity trustee (a "Member Trustee").

64 The term of office for a Charity Trustee shall be 3 years. Charity Trustees must retire at the end of their term of office but Retiring Charity Trustees may then be re-elected under clause 65 .

65 A Charity Trustee retiring at an AGM will be deemed to have been re-elected unless:-
65.1 He/she advises the board prior to the conclusion of the AGM the he/she does not wish to be re-appointed as a charity trustee; or
65.2 An election process was held at the AGM and he/she was not among those elected/re-elected through that process; or
65.3 A resolution for the re-election of that charity trustee was put to the AGM and was not carried.

## Appointment/re-appointment: Co-opted Trustees

66 In addition to their powers under clause 68, the board may (subject to clauses 61 and 65) at any time appoint any non-member of the organisation (providing he/she is willing to act) to be a charity trustee (a "Co-opted Trustee") either on the basis that he/she has been nominated by "a body with which the organisation has close contact in the course of its activities" or on the basis that he/she has specialist experience and/or skills which could be of assistance to the board.

67 At the conclusion of each AGM, all of the Co-opted Trustees shall retire from office - but shall then be eligible for re-appointment under clause 66.

## Termination of office

68 A charity trustee will automatically cease to hold office if: -
68.1 he/she becomes disqualified from being a charity trustee under the Charities and Trustee Investment (Scotland) Act 2005;
68.2 he/she becomes incapable for medical reasons of carrying out his/her duties as a charity trustee - but only if that has continued (or is expected to continue) for a period of more than six months;
68.3 (in the case of a Member Trustee) he/she ceases to be an Ordinary member of the organisation;
68.4 he/she becomes an employee of the organisation;
68.5 he/she gives the organisation a notice of resignation, signed by him/her;
$68.6 \mathrm{he} /$ she is absent (without good reason, in the opinion of the board) from more than three consecutive meetings of the board - but only if the board resolves to remove him/her from office;
68.7 he/she is removed from office by resolution of the board on the grounds that he/she is considered to have committed a serious breach of the code of conduct for charity trustees (as referred to in clause 850);
68.8 he/she is removed from office by resolution of the board on the grounds that he/she is considered to have been in serious or persistent breach of his/her duties under section 66(1) or (2) of the Charities and Trustee Investment (Scotland) Act 2005; or
$68.9 \mathrm{he} /$ she is removed from office by a resolution of the members passed at a members' meeting.

69 A resolution under paragraph 68.7, 68.8 or 68.9 shall be valid only if: -
69.1 the charity trustee who is the subject of the resolution is given reasonable prior written notice of the grounds upon which the resolution for his/her removal is to be proposed;
69.2 the charity trustee concerned is given the opportunity to address the meeting at which the resolution is proposed, prior to the resolution being put to the vote; and
69.3 (in the case of a resolution under paragraph 68.7 and 68.8) at least two thirds (to the nearest round number) of the charity trustees then in office vote in favour of the resolution.

## Register of charity trustees

The board must keep a register of charity trustees, setting out
70.1 for each current charity trustee:
70.1.1 his/her full name and address;
70.1.2 the date on which he/she was appointed as a charity trustee; and
70.1.3 any office held by him/her in the organisation;
70.2 for each former charity trustee - for at least 6 years from the date on which he/she ceased to be a charity trustee:
70.2.1 the name of the charity trustee;
70.2.2 any office held by him/her in the organisation; and
70.2.3 the date on which he/she ceased to be a charity trustee.

71 The board must ensure that the register of charity trustees is updated within 28 days of any change:
71.1 which arises from a resolution of the board or a resolution passed by the members of the organisation; or
71.2 which is notified to the organisation.

72 If any person requests a copy of the register of charity trustees, the board must ensure that a copy is supplied to him/her within 28 days, providing the request is reasonable; if the request is made by a person who is not a charity trustee of the organisation, the board may provide a copy which has the addresses blanked out - if the SCIO is satisfied that including that information is likely to jeopardise the safety or security of any person or premises.

## Office-bearers

73 The charity trustees must elect (from among themselves) a chair and a treasurer.

74 In addition to the office-bearers required under clause 73 , the charity trustees may elect (from among themselves) further office-bearers if they consider that appropriate.

75 All of the office-bearers will cease to hold office at the conclusion of each AGM, but may then be re-elected under clause 73 or 74 .

76 A person elected to any office will automatically cease to hold that office: -
76.1 if he/she ceases to be a charity trustee; or
76.2 if he/she gives to the organisation a notice of resignation from that office, signed by him/her.

## Powers of board

77 Except where this constitution states otherwise, the organisation (and its assets and operations) will be managed by the board; and the board may exercise all the powers of the organisation.

78 A meeting of the board at which a quorum is present may exercise all powers exercisable by the board.

79 The members may, by way of a resolution passed in compliance with clause 47 (requirement for two-thirds majority), direct the board to take any particular step or direct the board not to take any particular step; and the board shall give effect to any such direction accordingly.

## Charity trustees - general duties

80 Each of the charity trustees has a duty, in exercising functions as a charity trustee, to act in the interests of the organisation; and, in particular, must:-
80.1 seek, in good faith, to ensure that the organisation acts in a manner which is in accordance with its purposes;
80.2 act with the care and diligence which it is reasonable to expect of a person who is managing the affairs of another person;
80.3 in circumstances giving rise to the possibility of a conflict of interest between the organisation and any other party:
80.3.1 put the interests of the organisation before that of the other party;
80.3.2 where any other duty prevents him/her from doing so, disclose the conflicting interest to the organisation and refrain from participating in any deliberation or decision of the other charity trustees with regard to the matter in question;
80.4 ensure that the organisation complies with any direction, requirement, notice or duty imposed under or by virtue of the Charities and Trustee Investment (Scotland) Act 2005.

81 In addition to the duties outlined in clause 80, all of the charity trustees must take such steps as are reasonably practicable for the purpose of ensuring: -
81.1 that any breach of any of those duties by a charity trustee is corrected by the charity trustee concerned and not repeated; and
81.2 that any trustee who has been in serious and persistent breach of those duties is removed as a trustee.

82 Provided he/she has declared his/her interest - and has not voted on the question of whether or not the organisation should enter into the arrangement - a charity trustee will not be debarred from entering into an arrangement with the organisation in which he/she has a personal interest; and (subject to clause 83 and to the provisions relating to remuneration for services contained in the Charities and Trustee Investment (Scotland) Act 2005), he/she may retain any personal benefit which arises from that arrangement.

83 No charity trustee may serve as an employee (full time or part time) of the organisation; and no charity trustee may be given any remuneration by the organisation for carrying out his/her duties as a charity trustee.

84 The charity trustees may be paid all travelling and other expenses reasonably incurred by them in connection with carrying out their duties; this may include expenses relating to their attendance at meetings.

## Code of conduct for charity trustees

85 Each of the charity trustees shall comply with the code of conduct (incorporating detailed rules on conflict of interest) prescribed by the board from time to time.

The code of conduct referred to in clause 85 shall be supplemental to the provisions relating to the conduct of charity trustees contained in this constitution and the duties imposed on charity trustees under the Charities and Trustee Investment (Scotland) Act 2005; and all relevant provisions of this constitution shall be interpreted and applied in accordance with the provisions of the code of conduct in force from time to time

## DECISION-MAKING BY THE CHARITY TRUSTEES

## Notice of board meetings

87 Any charity trustee may call a meeting of the board or ask the secretary to call a meeting of the board.

88 At least 7 days' notice must be given of each board meeting, unless (in the opinion of the person calling the meeting) there is a degree of urgency which makes that inappropriate.

## Procedure at board meetings

89 No valid decisions can be taken at a board meeting unless a quorum is present; the quorum for board meetings is 3 charity trustees, present in person.

90 If at any time the number of charity trustees in office falls below the number stated as the quorum in clause 89 , the remaining charity trustee(s) will have power to fill the vacancies or call a members' meeting - but will not be able to take any other valid decisions.

91 The chair of the organisation should act as chairperson of each board meeting.
92 If the chair is not present within 15 minutes after the time at which the meeting was due to start (or is not willing to act as chairperson), the charity trustees present at the meeting must elect (from among themselves) the person who will act as chairperson of that meeting.

93 Every charity trustee has one vote, which must be given personally.
94 All decisions at board meetings will be made by majority vote.
95 If there is an equal number of votes for and against any resolution, the chairperson of the meeting will be entitled to a second (casting) vote.

96 The board may, at its discretion, allow any person to attend and speak at a board meeting notwithstanding that he/she is not a charity trustee - but on the basis that he/she must not participate in decision-making.

97 A charity trustee must not vote at a board meeting (or at a meeting of a subcommittee) on any resolution which relates to a matter in which he/she has a personal interest or duty which conflicts (or may conflict) with the interests of
the organisation; he/she must withdraw from the meeting while an item of that nature is being dealt with.

For the purposes of clause 97: -
98.1 an interest held by an individual who is "connected" with the charity trustee under section 68(2) of the Charities and Trustee Investment (Scotland) Act 2005 (husband/wife, partner, child, parent, brother/sister etc) shall be deemed to be held by that charity trustee;
98.2 a charity trustee will be deemed to have a personal interest in relation to a particular matter if a body in relation to which he/she is an employee, director, member of the management committee, officer or elected representative has an interest in that matter.

## Minutes

99 The board must ensure that proper minutes are kept in relation to all board meetings and meetings of sub-committees.

100 The minutes to be kept under clause 99 must include the names of those present; and (so far as possible) should be signed by the chairperson of the meeting.

## ADMINISTRATION

## Delegation to sub-committees

101 The board may delegate any of their powers to sub-committees; a subcommittee must include at least one charity trustee, but other members of a sub-committee need not be charity trustees.

102 The board may also delegate to the chair of the organisation (or the holder of any other post) such of their powers as they may consider appropriate.

103 When delegating powers under clause 101 or 102, the board must set out appropriate conditions (which must include an obligation to report regularly to the board).

104 Any delegation of powers under clause 101 or 102 may be revoked or altered by the board at any time.

105 The rules of procedure for each sub-committee, and the provisions relating to membership of each sub-committee, shall be set by the board.

## Operation of accounts

Subject to clause 107, the signatures of two out of three signatories appointed by the board will be required in relation to all operations (other than the lodging of funds) on the bank and building society accounts held by the organisation; at least one out of the two signatures must be the signature of a charity trustee.

107 Where the organisation uses electronic facilities for the operation of any bank or building society account, the authorisations required for operations on that account must be consistent with the approach reflected in clause 106.

## Secretary

108 The board shall appoint a secretary, and on the basis that the term of the appointment, the remuneration (if any) payable to the secretary, and the such conditions of appointment shall be as determined by the board; the secretary may be removed by them at any time.

## Accounting records and annual accounts

109 The board must ensure that proper accounting records are kept, in accordance with all applicable statutory requirements.

110 The board must prepare annual accounts, complying with all relevant statutory requirements; if an audit is required under any statutory provisions (or if the board consider that an audit would be appropriate for some other reason), the board should ensure that an audit of the accounts is carried out by a qualified auditor.

## MISCELLANEOUS

## Winding-up

111 If the organisation is to be wound up or dissolved, the winding-up or dissolution process will be carried out in accordance with the procedures set out under the Charities and Trustee Investment (Scotland) Act 2005.

112 Any surplus assets available to the organisation immediately preceding its winding up or dissolution must be used for purposes which are the same as or which closely resemble - the purposes of the organisation as set out in this constitution.

## Alterations to the constitution

113 This constitution may (subject to clause 114) be altered by resolution of the members passed at a members' meeting (subject to achieving the two thirds majority referred to in clause 47) or by way of a written resolution of the members.

114 The Charities and Trustee Investment (Scotland) Act 2005 prohibits taking certain steps (eg change of name, an alteration to the purposes, amalgamation,
winding-up) without the consent of the Office of the Scottish Charity Regulator (OSCR).

## Interpretation

115 References in this constitution to the Charities and Trustee Investment (Scotland) Act 2005 should be taken to include: -
115.1 any statutory provision which adds to, modifies or replaces that Act; and
115.2 any statutory instrument issued in pursuance of that Act or in pursuance of any statutory provision falling under paragraph 115.1 above.

116 In this constitution: -
116.1 "charity" means a body which is either a "Scottish charity" within the meaning of section 13 of the Charities and Trustee Investment (Scotland) Act 2005 or a "charity" within the meaning of section 1 of the Charities Act 2011, providing (in either case) that its objects are limited to charitable purposes;
116.2 "charitable purpose" means a charitable purpose under section 7 of the Charities and Trustee Investment (Scotland) Act 2005 which is also regarded as a charitable purpose in relation to the application of the Taxes Acts.
